### **THE AIMS AND OBJECTIVES OF THE CONFERENCE PROGRAM**

The issue of broadly understood economic security becomes particularly important in the era of strong internationalization and globalization of economic processes. At the same time, this issue applies to all entities, both natural and legal persons. Whereas, the 20th century has already proved that the economic strength of the country, apart from the military potential, enables it to oppose all kinds of external threats. Stability and the security of the internal market strongly support the development of social capital. These and related issues require continuing scientific reflection. These discussions are to be followed by the 8th International Conference on Science from the Business, Administration and Security cycle.

Our invitation to the conference is addressed to researchers working in the fields of economic, law and security sciences, as well as security pedagogy. Our invitation is also addressed to practitioners: police officers, the judiciary, employees of corporate security guarding structures and representatives of local government.

## THE THEMATIC AREAS OF THE CONFERENCE

### 1. Economic crime and its combating

- corruption threats in key enterprises (sectors) crucial for the state economy;
- fight against the economic underground in Poland and in the world;
- combating tax crime (tax scandals - case studies);
- procedures for prosecuting fiscal and economic crimes.

### 2. Safety management of business transactions

- security of the banking system in a crisis situation; financial risk management;
- financial security of business entities;
- the cyberterrorism and cyber security in business administration (case studies);
- information security in business and public activities;
- the intelligence and counterintelligence;
- the energetic safety;
- security audits in enterprises (sectors) that are key to the state economy;
- contemporary problems of economic war;
- the manipulation of economic law;
- humanitarian catastrophes and economic security management;
- social conflicts and economic security;
- war conflicts and economic security;
- economic security in the context of the national security strategy;
- energy security management;
- business insurance in the practice of insurers;
- transport safety management (maritime, air, rail, road).

### 3. Legal, administrative and educational aspects of economic security management

- excessive length of court proceedings in commercial cases and the stability of an economic entity;
- peculiarities of social processes as the cause of uncertainty in making economic decisions;
- debt collection and enforcement in the context of financial security;
- public or social security - conceptual dilemmas;
- the estimation of insurance risk;
- education for safety (consumer rights, consumer bankruptcy, tax education, physical security, property security, education for health and environmental safety).
