## **Terms and Conditions**

1. The organizer of the conference entitled "**Crafting Legal Solutions for Modern Business Realities: Economic and Commercial Law Conference**" (hereinafter referred to as the "Conference"), is the Scientific Circle of Economic and Commercial Law at the University of Business and Administration of Eugeniusz Kwiatkowski in Gdynia, located at: 81-303 Gdynia, Kielecka 7 Street (hereinafter referred to as the "Organizer").

2. The conference will be held on June 8, 2024, at the organizer's headquarters and in a remote format.

3. The conference is aimed at a wide audience interested in the topics of economic and commercial law.

4. The conference will include expert panels and student panels with discussion sessions following each.

- 5. Participation in the conference entitles the participant to:
  - a) participation in the conference;
  - b) participation in discussions in the selected thematic section;
  - c) receiving a certificate confirming participation in the conference.

## **Conference Participation Rules**

  - for passive participation June 5, 2024.

10. Active participants may withdraw from participating in the conference. However, passive participants are not required to inform the organizer about their withdrawal from participating in the conference.

## **Final Provisions**
